#### Motion to Approve President's Contract

Chair Custer made a motion that Victoria L. Bastecki-Perez, Ed.D., be appointed President of the Montgomery County Community College, and that the appropriate officers of the Board of Trustees be authorized to execute the Employment Agreement, which is for a term of three (3) years with an annual base salary of \$245,000. Trustee Guttha seconded the motion and the Board of Trustees unanimously approved Dr. Bastecki-Perez as the 6<sup>th</sup> President of Montgomery County Community College.

The Trustees congratulated Dr. Bastecki-Perez for moving the College forward during the pandemic and applauded her outstanding leadership.

Dr. Bastecki-Perez noted that she feels honored and privileged to serve as the 6<sup>th</sup> President and personally thanked the Board of Trustees for their support for advancing the College's strategic agenda. She continued to thank administrators, faculty and staff, along with Government Officials, Business & Industry, K-12 partners, our more than 65,000 alumni, students, donors and investors. She also thanked her mother, husband, daughter and her two step-daughters for their support. She is humbled and truly grateful for this opportunity.

Newly appointed President Bastecki-Perez, provided an overview of the May 2020 Interim President's Report which will be updated to the President's Report. She noted that the Emergency Student Aid Campaign raised over \$61,000. The College held an online open house with over 375 attendees. She also noted that the College has held a tuition freeze four years in a row.

President Bastecki-Perez noted that she wrote a Letter to the Editor and an Op-Ed on the COVID-19 pandemic and the unique benefits community colleges offer. This was shared on NISOD, PA Commission for Community Colleges, AACC, Montco Today, The Mercury, The Reporter, The Times Herald, The Daily Local and five area weekly newspapers.
