COURSE DESCRIPTION:

This course will explore the historical development as well as the contemporary techniques in salt glazing stoneware pottery. Assignments will involve students in the various approaches to this ceramic technique, from slip glaze application to fuming the kiln. This course is subject to a course fee. SEQUENCE OF TOPICS:

1. Mix Two 100 Gram Slip Glaze Tests
Apply to a Test Tile for Salt Glazing
2. Form Two Pottery Vessels at Least 8 Inches in One Measurement. Use Several Slip Glazes on One to Create a "Busy" Surface. On the Other Create a "Quiet" Surface

3. Form a Low Wide Bowl (12 Inches) Using Cut-Outs as Stencils for Slip Glaze Applications along with Other Decoration Techniques as Desired
4. Sketch and Make a Vessel with a Lid. Use a Slip Glaze or Glaze as a Liner and Sale Glaze Wax to Separate the Lid and Vessel
5. Create a Pottery Piece That Incorporates an Extruded Element as a Part of the Total Concept
