Montgomery County Community College ESW 245 Safety and First Aid 3-3-0

COURSE DESCRIPTION:

This course is designed to develop and provide the citizen responder with the knowledge and skills necessary to help sustain life and minimize the consequences of injury or sudden illness until advanced medical care arrives. American Heart Association certifications in Heartsaver First Aid; Adult/Child and Infant Cardiopulmonary Resuscitation (CPR) and Automated External Defibrillator (AED) are available upon meeting certification requirements.  - 2. Measures for prevention of cross contamination when using practice manikins
 - 3. Safety precautions observed for students with physical conditions which limit participation in some skill practice sessions
 - 4. Individualized adaptation of practice sessions for students with physical limitations

 - 1. Check Call Care
 - 2. Compression Airway Breathing (CAB)
- D. Life-Threatening Emergencies
 - 1. Breathing emergencies
 - 2. Cardiac emergencies/AED procedures

 - 1. Soft tissue injuries
 - 2. Musculoskeletal injuries
 - 3. Injuries to the head and spine
 - 4. Injuries to the chest, abdomen, and pelvis
- F. Medical Emergencies: Sudden Illness
 - 1. Definition, recognition, and general principles of care
 - 2. Acute (rapidly occurring) medical problems and emergencies: Prevention of, recognition of, and care for each
 - 3. Chronic (slowly developing) medical problems and/or emergencies
- G. Rescue: Reaching and Moving Victims
- H. Delayed Help: Wilderness Emergencies
- I. Diversity Adaptations
 - 1. Implications and adaptations of first aid on victims from select religious and/or ethnic groups
 - 2. Influences of age, gender, and socioeconomic status on: risk of injury and/or sudden illness; reaction to injury and/or sudden illness; response to care; legal responsibilities of citizen responders
 - 3. First aid care for the handicapped and/or disabled
