### Montgomery County Community College HIS121 World Civilizations I: To 1500 3-3-0

### COURSE DESCRIPTION:

A survey of world civilizations covers the period from prehistory to the sixteenth century. The course begins with the origin of humans, first river valley civilizations, empirebuilding, foundations of the great world religions, and then proceeds to look at the rise of Europe. The Renaissance and the early explorers will conclude the course. Government, societal, economic, cultural, and religious aspects are analyzed throughout the course.
