Montgomery County Community College MUS 151 Guitar Class 2 1-1-2

COURSE DESCRIPTION:

Guitar Class 2 is a course designed to continue to develop skills introduced in Guitar Class 1. The course is also open to students who can demonstrate fluency with the guitar comparable to that achieved in Guitar Class 1. Students will expand their knowledge of standard musical notation as it applies to guitar repertory. Students will be introduced to the more advanced techniques of guitar playing, including strumming and finger-style techniques. Through repertory study students will also learn about the history and repertory of the guitar within both western and other cultures. This course is subject to a course fee. Aggregated results will be submitted to the Associate Vice President of Academic Affairs. The benchmark for each learning outcome is that 70% of students will meet or exceed outcome criteria.

SEQUENCE OF TOPICS:

Each topic will take 1-2 weeks.

- 1. Review of previous semester's material. Full F and C7 chords.
- 2. Four string bar chords, major and minor. Suspended 4th chords. Chord embellishments.
- 3. Using a capo. Patterns 1-2 in right-hand accompaniment packet.
- 4. Five string bar chords: Major and minor. Patterns 3-4 in packet.
- 5. Five string bar chords: Dominant 7th chords.
- 6. Patterns 5-6 in packet.
- 7. Chord transpositions. Six string major bar chords.
- 8. Six string minor bar chords. Patterns 7-8 in packet.
- 9. Six string dominant 7th bar chords. Walking bass patterns.
- 10. Natural and Harmonic minor scales. Suspended 2nd and 6th chords.
- 11. Alternating bass patterns.
