COURSE DESCRIPTION:

This course introduces the student to concepts of nursing providing the foundation for professional nursing practice and the framework for the nursing program. The concepts of nursing reflect safe, client-centered care, which are met through teamwork and collaboration among health care disciplines. Emphasis is placed on understanding the concepts of nursing applied to professional nursing practice. This is a non-clinical course subject to a course fee. REQUISITES:

Previous Course Requirements

Option 1

- Placement into or completion of Anatomy and Physiology I (BIO 131)
- TEAS composite score of 75% or greater
- TEAS Reading Comprehension score of 75% or greater

Option 2

- “B” or better in BIO 131, BIO 132 or BIO 140
 - TEAS composite score of 65% or greater
 - TEAS Reading Comprehension score of 75% or greater
- High School Diploma or equivalent on file at the college prior to registration for NUR 108.
 - NUR 108 may only be one year old when students enter the clinical component of the Nursing Program.

Previous or Concurrent Course Requirements

BIO 131 – Human Anatomy and Physiology I- with a minimum grade of “C” within 5 years

BIO 140 – Microbiology and Immunology- with a minimum grade of “C” within 5 years

MAT106 – Math Applications – with a minimum grade of “C” within 5 years
