Montgomery County Community College NUR 211 Nursing Care of Clients with Complex Health Care Needs 8-4-12

COURSE DESCRIPTION:

This course focuses on the use of the nursing process to assist clients across the lifespan experiencing frequently seen complex healthcare needs.
