Ethical Issues Affecting Consumers and the Health Care Professions
3-3-0

COURSE DESCRIPTION:

This course addresses the needs of the health care consumer and the provider alike. Stemming from a philosophical base, this course will examine controversies emerging from rapid technological advances and modern health care practice. Conflicts discussed range from the person's right to choose or refuse a particular course of treatment to issues of euthanasia, genetic research, and human experimentation. Students are encouraged to participate in discussions of ethical problems reported in the popular media and to develop a personal decision-making system which can be applied to a variety of ethical issues. Emphasis is on critical analysis and the incorporation of theory to ethical deliberations.
